TRANSITIONS OF PA OFFERING SAFE AND SUPERVISED VISITATIONS

Since 2019, the Fairl Family Justice Center (FJC) has facilitated 517 supervised visitations, which started via Zoom due to COVID-19 restrictions. We have had the opportunity to help 61 families and had the pleasure of meeting 84 kids. It's amazing to see that more than half of our families have successfully reached their goals. whether it was family-planned or court-ordered. Just over this past holiday season, we were able to see the ability for a family to file for a modification right before December 25, which resulted in parties getting shared legal custody. The child started services at the FJC when they were just 2 years old, and now that they are 4, they've successfully ended their time at FJC. The program is free of charge to clients and provides monitored visitations. FJC Coordinator Olivares shared "It's amazing that the parent was able to be a part of the kiddo's growth. Providing these services ensured they didn't miss out on important milestones. Now, they can spend time together outside of the FJC and continue building their bond in their own safe place." Not every case is the same, but the ability to ensure a safe place to rebuild relationships for all parties is essential to the parent-child bond.

FROM THE DESK OF THE CEO, MAE-LING KRANZ:

FUTURE CUTS TO THE VICTIM OF CRIME ACT FUNDING THREATEN CRUCIAL SERVICES

In 2021, Congress passed the VOCA Fix to Sustain the Crime Victims Fund Act of 2021 to fix the long-term challenge of decreased deposits into the Crime Victims Fund (CVF). This structural change was, and still is, a critical first step for the long-term health of the CVF, and in the short term, it has produced much-needed additional dollars. Unfortunately, it has not generated the level of funding that was expected, and it has

not resolved the CVF's historically low balance.

The Victim of Crime Act (VOCA) fund balance has decreased 92% from \$13B in 2017 to a mere \$1.019B in 2023. This has resulted in Pennsylvania and all other states receiving significant decreases in their federal VOCA awards, which subsequently impacts the amount of VOCA dollars available for future funding to victim service organizations. The below-average deposits into the CVF place the projected fiscal year 2024 awards at \$700 million below fiscal year 2023 amounts, and 2023 is already the lowest funding level year since 2014. This federal budget projects a 41% decrease in federal awards to states.

Transitions of PA and like-funded victim services providers in Pennsylvania know our programs are receiving a 5% funding cut in fiscal year 2024. Although 5% may not seem like a large amount, to many victim service organizations, including Transitions, Victim of Crime Act funds make up the largest funding stream, and any cut ultimately hurts victims and survivors.

Further, the President's FY24 budget and the FY24 House and Senate Commerce, Justice, Science, and Justice agencies appropriations bills is a 40% cut compared to FY23. The devastating impact of this cut will fall hardest on the smallest programs, particularly programs in rural communities, low-income communities, and Communities of Color. Millions of people nationwide will lose access to lifesaving and life-sustaining services for victims of domestic violence, sexual assault, child abuse, and other crimes. Further proposed cuts will force programs to cut staff and services or close entirely, leaving victims without the essential support they need to heal, stay safe, and seek justice.

As the federal budget negotiations continue, a third continuing resolution was signed extending last fiscal year's spending levels until March 8, 2024. The National Association of VOCA Assistance Administrators is working with national partners and VOCA stakeholders to respectfully urge Congress to provide bridge funding to reinforce the Crime Victims Fund.

Victim service providers are working diligently with private funders and state and local lawmakers to secure funds to address increased needs and provide a buffer if VOCA grants are cut. However, even with these stopgaps, programs simply cannot absorb cuts of this magnitude. They are facing what can only be described as a catastrophe.

We need your help. Transitions of PA is imploring individuals throughout our community to reach out to our members of Congress and share with them what potential cuts to VOCA will mean for programs like ours, survivors in our communities, survivors across the state, and the nation. THE THREE TYPES OF CIVIL PROTECTION ORDER

Transitions' legal advocates spend most of their time helping clients obtain Protection from Abuse orders (PFAs), but there are two other types of civil protection orders with which we assist: Sexual Violence Protection Orders (SVPOs) and Protection from Intimidation orders (PFIs).

Protection from Abuse (PFA) orders apply to cases where one or more of the following acts occur between family or related household members, or current or former spouses or intimate partners:



- Attempting to cause, or intentionally, knowingly, or recklessly causing bodily injury, including rape or other forms of sexual assault;
- Placing another in reasonable fear of imminent bodily injury, including through threats;
- Falsely imprisoning someone (e.g. tying up, locking in a room, taking car keys, or otherwise restricting one's ability to move about freely); or
- Stalking (following or harassing in a manner that causes fear).

PFAs are not appropriate in cases where abuse occurs between unrelated household members, such as roommates.

Sexual Violence Protection Orders (SVPO) apply to cases of sexual violence where the victim and perpetrator have never had a family, household, or intimate partner relationship. Some examples of sexual violence perpetrators who may be subject to SVPOs are strangers, acquaintances, neighbors, co-workers, and friends.

Protection from Intimidation (PFI) orders apply to cases of stalking and harassment where the victim is under the age of 18 and the perpetrator is over 18. Again, the victim and perpetrator cannot have had a family, household, or intimate partner relationship, as those relationships fall under the purview of a PFA.

Adults and emancipated minors may file for their own protection orders. Parents, adult household members, and legal guardians, including court-appointed guardians ad litem, may file on behalf of minor children. Legal guardians may also file on behalf of incapacitated adults. Finally, victims do not have to report perpetrators' actions to police to qualify for a protection order.



February was Teen Dating Violence Awareness Month

Teen dating violence is a significant and prevalent issue, with studies indicating that at least one in twelve adolescents experience various forms of abuse within their dating relationships. It can occur across genders and sexual orientations, highlighting the need for increased awareness, education, and support to address and prevent this widespread problem.

Our key event will include a presentation on online safety issues for parents by a Special Agent from the FBI to be held at the Lewisburg High School Auditorium, on Tuesday, April 16, 2024, at 6:30 pm. We will also be observing <u>Denim Day</u>, on April 24, 2024, to show our support for sexual assault survivors and victims, alongside various other activities and happenings that will be listed on our website and social media outlets.

SAAM serves as a reminder of our shared responsibility to create a safer and more inclusive world for everyone. We can contribute to building a culture of respect, dignity, and empowerment by standing in solidarity with survivors and actively working towards prevention and intervention. Let us come together this April and beyond to amplify the voices of survivors, break down systems of oppression, and promote thriving communities where all individuals can live free from the fear of sexual violence and abuse. By working together, we have the power to make a difference.
